**CONTRACT AWARD**

- The Town Board will make the award of the contract at a public meeting.
- No contract shall be issued until the Contractor has furnished satisfactory proof of a liability insurance policy in full force and effect in a company authorized to do business in the State of Wisconsin for his total operation in the amount of a One Million Dollar (\$1,000,000) complete liability umbrella policy covering injury, death or destruction of property of any person other than the Contractor.
- A written notice of award will be given to the successful Contractor. The Contractor is required to execute the public contract and furnish required certificates of insurance within ten (10) calendar days from the date of the notice of award.

**PAYMENT SCHEDULE**

Payment shall be made within 30 days of receipt of a properly completed invoice or receipt and acceptance of the property or service, or in accordance with the payment schedule specified in the public contract. Claims for payment shall be filed with the Town Clerk. Claims are submitted to the Town Board for approval on the first Tuesday of each month.

**SCOPE OF CONTRACT**

The Town of Wascott is soliciting quotes for the purchase and hauling of salt-sand for the October 2010 through April 30, 2011 contract period.

Salt-sand will be delivered to the Town Hall site, located at 16362 S Town Hall Road, Wascott, WI. The Town shall designate the specific location for unloading of purchased materials.

Each delivery and the quantity of salt-sand purchased are subject to prior authorization by the designated Town Official.

All subcontracting shall be pre-approved by the Wascott Town Board. The prime contractor is responsible for all subcontractor(s) work and payment. The Town of Wascott will not pay any subcontractor or third parties directly.

Fuel surcharges will NOT be allowed during the contract term.
