- 1) <u>Call to Order/Roll Call</u> The meeting was called to order by Chair Boughner at 7:00 p.m. Board members present Chair Boughner, Supervisors Stapp, Burnside and Jenson, Clerk/Treasurer Atkinson and 11 guests. Supv Hanson was absent.

- 4) Public Comments Please be advised per § 19.84(2), comments and announcement will be received from the public. Comments are to be directed to the Town Board and limited to 4 minutes per person. No action taken by Board. Patti McDermott Food n' Fun Day will be Friday, June 8, 2018 at the Town Hall starting at 11:30 with a bucket raffle and lunch at noon. Looking for donations of bucket raffle items. All proceeds are donated to Northwood School for various projects. John Glindinning voiced his continued concerns on the effectiveness of the Town's gravel and wants it tested. Would like costs of what Town spends in relation to out sourcing the gravel. Chair Boughner commented there will be a Gordon/Wascott Joint Meeting to be held on May 22, 2018 at 6:00 p.m. at the Wascott Town hall to discuss Transfer Station issues and extended an invitation to all to attend.
- 5) <u>Department and Representative Announcements</u>
  - a) Fire Department Chief Michalek reported 4 medical calls. Questions on whether to burn go to the DNR website. Open House will be held on June 16 from 11-2 p.m. at the Fire Hall.
  - b) EMS Asst. Director Stacey Vig absent.
  - c) County Board Representative Mary Lou Bergman provided the following report
    - April County Board meeting was rescheduled to 4/12. Three supervisors John Robinson, Dave Connolly and Dan Corbin will be recognized for their years of service to Douglas County and the Board. All three will be leaving the Board. Reorganizational meeting will be 4/17 at which time new board members will be introduced and supervisors will prioritize list of committees;
    - Samantha Linden, a former Northwood School grad and UW-Madison junior, has been interning in Senator Bewley's capitol office;
    - Tax deed notices have been sent out. If you know someone in real estate tax trouble, encourage them to contact the Douglas County Treasurer;
    - A new policy has been enacted for non-profit agencies requesting funding from Douglas County Capital project funds. A complete written application must be completed along with specific documentation. Applicants must provide services beneficial to Douglas County along with a 991.
    - Lack of birds becoming noticeable and DNR thinks it is due to possible West Nile Virus;
    - Deer Farm in Bayfield County that has deer brought in from down state, is testing for possible CWD;
    - Towns have expressed concern of viability of Comp Plan Committees. We can't tell Towns what to do, however, it is currently the opinion of those in control, that Towns not be too quick to disband. It seems legislative control *is* changing. It might be more beneficial to Towns to adjust committee responsibilities, and/or meeting requirements.
    - Mary Lou thanked all who supported her in the recent election and will continue to be responsible to the citizens of the districts represented;
